NOTIFICATION
Dated Dispur, the 18th December' 2019

No. PMA.329/2012/194 : The Governor of Assam is pleased to adopt the following 03 (three) models for the Upper Primary level schools of the State, facilitating several mother tongues (other than Assamese) spoken by different communities of the State to be incorporated in the curriculum for Elementary level from the next Academic Sessions, as a part of Language Strategy Document of SCERT Assam.

1. Model (A): (Upper Primary – Assamese Medium)

L1 = Assamese

L2 = English

L3 + L4 = L3 50% Hindi + L4 50%

(Bodo / Bengali / Garo / Manipuri / Nepali / Tiwa / Tai / Rabha /

Deori / Mising / Bishnupriya Manipuri / Sanskrit / Arabic)

Or L3 = 100% Hindi

2. Model (B): (Upper Primary – Bengali Medium)

L1 = Bengali / L2 = English / L3 + L4 = L3 Assamese 50% + L4 50%

(Bodo / Hindi / Garo / Manipuri / **Nepali** / Tiwa / Tai / Rabha / Deori / Mising / Bishnupriya Manipuri / Sanskrit / Arabic)

Or

L3 = 100% Assamese

3. Model (C):

(Upper Primary – Bodo Medium) -L1 = Bodo /L2 = English /L3 + L4 = L3 Assamese 50% + L4 50%

(Bengali / Hindi / Garo / Manipuri / Nepali / Tiwa / Tai / Rabha / Deori / Mising / Bishnupriya Manipuri / Sanskrit / Arabic)

Or

L3 = 100% Assamese

* There will be similar models for schools with medium of instruction other than Assamese, English and Hindi. L2 will be Assamese for

English medium schools. L3 will be Hindi for Assamese and English medium schools. L3 will be Assamese for Hindi medium schools.

** L4 cannot be the same as L1 (MOI) or L2 or L3 for students who opt for L4.

Further, Nepali language is hereby withdrawn as a medium of instruction as the Nepali speaking students would like to opt for Assamese / Hindi / English medium. However, Nepali language shall be retained as a subject.

This comes into force with immediate effect.
